Excerpts from the EVOA Constitution

ELECTION OF OFFICERS

ARTICLE VI

Section 2 Determination of Candidates for Office (Qualifications)

- A. Candidates for an office in the Council EVOA must be present at the election.
- B. Candidates must be a registered Explorer, Venturer, or Sea Scout and maintain their registration in a post, crew, or ship for the full term of office following the election.
- C. Candidates must agree to physically reside in the territorial boundaries of the Greater St. Louis Area Council for the term of office.
- D. Candidates must be under the age of 21 at the time of their election to office.

COUNCIL EVOA OFFICERS AND THEIR RESPONSIBILITIES

ARTICLE VIII

Section 1 Officers

A. Council EVOA President

- 1) Presides at all Council EVOA meetings and activities.
- 2) Serves as Chairman for the EVOA Executive Committee.
- 3) Appoints Sub-committee Chairmen and supervises work of all officers and sub-committees.
- 4) Serves as a member of the Council Exploring & Venturing Executive Committee. Works with the Council EVOA Advisor and Director of Exploring & Venturing to coordinate the council Exploring & Venturing program, policies, and calendars.

B. Council EVOA 1st Vice President (Administration)

- 1) Substitute for the Council EVOA President in his/her absence.
- 2) Responsible for updating the post, crew, ship president's list, membership and administration. Maintain contact with Area/District and Association EVOA officers and unit presidents.
- 3) Perform any duties which, may be assigned by the Council EVOA President.
- 4) Works with the Council EVOA Advisor and Director of Exploring & Venturing.

C. Council EVOA 2nd Vice President (Program)

- 1) Substitutes for the 1st Vice President when necessary.
- 2) Assists in the appointment of event and activity chairpersons in supervising all program committees.
- 3) Perform any duties, which may be assigned by the Council EVOA President.
- 4) Works with the Council EVOA Advisor and Director of Exploring & Venturing.

D. Council EVOA Secretary

- 1) Prepares minutes of all Council EVOA meetings. Prepare minutes of all EVOA Executive Committee meetings.
- 2) Responsible for all correspondence for the Council EVOA (meeting notices and EVOA newsletters).
- 3) Performs any duties, which may be assigned by the Council EVOA President.
- 4) Works with the Council EVOA Advisor and Director of Exploring & Venturing.
