

Volunteer Service Award for Law Enforcement Explorers

SPONSORED BY THE FEDERAL INVESTIGATORS' ASSOCIATION

The Federal Investigators' Association (FIA) selects one or more currently participating law enforcement Explorers as the recipient(s) of the National Law Enforcement Explorer Volunteer Service Award. The award consists of a plaque, a U.S. savings bond, and recognition in the association's newsletter.

The award is given in recognition of "the unusually generous commitment of time, effort, initiative, cooperation, and cheerfulness to service within the sponsoring department or agency by an active law enforcement Explorer."

The Award

Each selected Explorer will receive a plaque and a savings bond.

Selection Criteria

The key selection factors will involve the individual Explorer's contribution in service as a volunteer in the activities of the sponsoring department or agency. This contribution will be considered in terms of the time expended, level of effort, and quality of service performed. Time spent in post leadership and post promotion alone are not an element of this award. This would not exclude the time a post leader spent while involved in post support to the sponsoring department (i.e., crowd control, parking, police desk, or office assistance). The major elements to be considered for the award will be the amount of time spent in the calendar year performing service to the department; the levels of effort and initiative displayed; organizational ability demonstrated; the quality and importance of the work performed; the personal responsibility and positive attitude toward community service displayed; and the level of cooperation with post and department personnel as well as others in the community.

Nominating Procedure

The department head or other senior department official of any law enforcement organization which sponsors a law enforcement Explorer post can nominate annually one Explorer for the award. The Explorer must have been an active participant of that post for the entire calendar year for which nominated and still be an active Explorer or participating adult when selected for the award. To nominate an individual, the following procedure should be used:

1. The Advisor and committee oversee the preparation and completion of the National Law Enforcement Explorer Volunteer Service Award nomination form, which is a part of this brochure.
2. The post Advisor, assistant Advisor, a post committee member, or an appropriate organization official must prepare a statement of no more than 1,000 words on department letterhead that describes the service to the department for which the Explorer is being nominated for the award. Specific description of the nominee's performance must be provided. Include the following:
 - Category or type of service performed and total hours expended
 - Levels of effort and initiative displayed
 - Organizational ability demonstrated
 - Quality and importance of work performed
 - Personal responsibility and positive attitude toward community service displayed
 - Level of cooperation with post and departmental personnel as well as others in the community
 - Statement of personal conduct and character.

3. The department head or other senior official prepares an endorsing letter on organization letterhead describing the overall impact of the nominee's service to the organization.
4. The post committee forwards the complete nomination package to the local council Learning for Life committee.

Secure the Learning for Life certification at your local office and then forward the original and one copy of the [nominating package](#) to National Law Enforcement Scholarships and Awards, 1325 West Walnut Hill Lane, P.O. Box 152079, Irving, TX 75015-2079.

Learning for Life will furnish the president of the FIA with information concerning approved nominees. The FIA president will appoint a committee to select the award recipient(s) and notify Learning for Life of the results. The award winner(s) will be recognized at the biennial national law enforcement Explorer conference or at an appropriate ceremony coordinated through the local office.
